# Notice on Food Stall Application

~Every year we celebrate our International Day  
with various dances, songs and food presentations~

Please read and understand the following before participating

1. The number of stalls is limited. If there are too many applicants, the number will be determined by drawing lots. Please understand this in advance. All stalls and stages will be located in the parking lot on the Cathedral grounds. In case of rain, non-food stalls will be located indoors.
2. Please pay **the 5,000 yen stall fee** at the headquarters on the day of the event, prior to the start of the social event.
3. Each stall will be provided with one long desk and two folding chairs. All other items are to be provided by each vendor. (Booth space is half the size of a large tent, 2.7m wide x 3.4m deep)
4. If heating cookers like grills, portable gas stoves, or LPG · L P gas are used, a fire extinguisher should be prepared and placed in each booth. Without a fire extinguisher a food stall with a heating cooker cannot be opened.
5. No power and water available.
6. After the decision to open a booth is made, a notice, booth number, a map of nearby parking lots, and a carry-in/out permit (if necessary) will be sent to the applicant's address. Please present the "Carry-in/out Permit" on your dashboard when you use your car for carry-in/out. After entering the venue, please unload your goods and exit the venue promptly following the instructions. There are no parking spaces available on the day of the exhibition. Please do not park on the surrounding streets.
7. About the garbage or trash, you are responsible for your own garbage/trash. Please provide a garbage bag beside/in front of your stall. Do not leave it within the premises of St. Mary's Cathedral.
8. Please observe proper hygiene and sanitation. Wash hands and cook well and thoroughly.
9. Cancellation of the activity (as perceived by the city government or the diocese) may happen. Ex: New coronavirus outbreak status, disasters, influenza pandemic.
10. The Holy Mass will be celebrated in the Cathedral from 11 am. While the mass is going on, selling and eating of food are prohibited. The time of the event must be strictly observed.
